On the 20th day of August, 2007, this cause was called for trial, and the State appeared by her Assistant District Attorney, J. Patrick Murphy, and the defendant, Ronnie Duane Mason, appeared in person in open court, defendant's counsel, Selden Hale and Maxwell Peck, also being present, and the said defendant having been duly arraigned, and having pleaded Not Guilty to the indictment Herein, both parties announced ready for trial, and thereupon a jury, to-wit: Emilia Chacon-Ulibania and the others, was duly selected, impaneled and sworn, who having heard the indictment read and the others, was duly selected, impaneled and sworn, who having heard the indictment read and the parties of Not Guilty thereto, and having heard the evidence submitted, been duly charged by POTTER COUNTY, TEXAS

the court, and having heard arguments of counsel, retired in charge of the proper officer to consider the verdict, and afterward were brought into court by the proper officer, the defendant and defendant's counsel being present, and returned into open court the following verdict which was received by the Court and is now entered upon the Minutes of the Court, to-wit:

"We, the jury, find the defendant, <u>RONNIE DUANE MASON</u>, guilty of the offense of Capital Murder, as alleged in the indictment.

THEREUPON on the 29th day of August, 2007, this cause being again called, the State Appeared by her Assistant District Attorney, J. Patrick Murphy, and the defendant, appeared in person, his counsel, Selden Hale and Maxwell Peck, also being present, being called to assess the punishment, evidence was presented to the same jury on the special issues pertaining to punishment. After the same jury heard all the evidence presented by the State and the defendant on the special issues pertaining to punishment, the Court charged the jury as provided by law on the following special issues:

It is therefore CONSIDERED and ADJUDGED by the Court that the defendant, Ronnie Duane Mason, is guilty of the offense of Capital Murder as found by the jury.

It is, therefore, the ORDER of the Court that the defendant, <u>Ronnie Duane Mason</u>, be punished by having a Life sentence in the Texas Department of Criminal Justice, Institutional Division, assessed against him.

Thereupon the defendant, <u>Ronnie Duane Mason</u>, was asked by the Court whether he had anything to say why said sentence should not be pronounced against him and he answered nothing in bar thereof, whereupon the Court proceeded, in the presence of the defendant, <u>Ronnie Duane Mason</u>, to pronounce sentence against him as follows:

Whereas, the defendant, <u>Ronnie Duane Mason</u>, has been adjudged to be guilty of Capital Murder by the jury; and the law providing that on such jury finding the Court shall sentence the defendant to Life in the Texas Department of Criminal Justice, Institutional Division.

It is, therefore, the ORDER of the Court that the defendant, <u>Ronnie Duine Mason</u>, is sentenced to Life in the Texas Department of Criminal Justice, Institutional Division, and the defendant was

informed of the defendant's right to appeal and that the defendant was entitled to have counsel appointed by the Court to perfect an appeal if the defendant could not afford to employ counsel for said appeal.

Jail Credit allowed is: In 8/12/04 to present.

The defendant, Ronnie Duane Mason, is now remanded to the custody of the Sheriff of Potter County, Texas, to be transported to the Institutional Division of the Texas Department of Criminal Justice.
