It is also FURTHER ORDERED that pursuant to Section 11.101 of the Texas Civil Practice and Remedies Code, Plaintiff Richard Payne, TDCJ-CID No. 620984 is hereby prohibited from filing, in propria persona, a new litigation in a court in the State of Texas without first obtaining approval of a local administrative jude.

It is also FURTHER ORDERED that the Clerk of the Court shall forward a copy of this Order to the Office of Court Administration of the Texas Judicial System in accordance with Section 11.104(a) of the Texas Civil Practice & Remedies Code.
