THE FOLLOWING AMENDED RULE IS MADE TO THE LOCAL RULES OF EL PASO COUNTY IN REFERENCE TO "RULE 8.01 NON-JUDICIAL PERSONNEL (C) AND (D)" AS FOLLOWS:

PART EIGHT NON-JUDICIAL PERSONNEL

RULE 8.01 NON-JUDICIAL PERSONNEL:

- (A) THE LOCAL ADMINISTRATIVE JUDGE OF THE COUNTY SHALL SUPERVISE THE OFFICE OF COURT ADMINISTRATION AND SHALL BE RESPONSIBLE FOR ALL ADMINISTRATIVE MATTERS PECULIAR TO THE COURTS AS DISTINGUISHED FROM JUDICIAL MATTERS.
- (B) THE LOCAL ADMINISTRATIVE JUDGE SHALL PERIODICALLY REVIEW THE CASE FLOW PROCEDURES AND OPERATIONS OF THE COURT ADMINISTRATION AND SHALL RECOMMEND NECESSARY CHANGES TO THE JUDGES OF THE DISTRICT COURTS AND STATUTORY COUNTY COURTS AT LAW.
- (C) EACH JUDGE SHALL BE RESPONSIBLE FOR SEEING THAT HIS OR HER **STAFF AND** NON-JUDICIAL PERSONNEL ARE PROMPT AND WELL-QUALIFIED FOR THEIR DUTIES.
- (D) **STAFF AND** NON-JUDICIAL PERSONNEL ~~SHOULD~~ **SHALL** OBSERVE THE STANDARDS OF DECORUM AND CONDUCT SET FORTH IN THE CODE OF JUDICIAL CONDUCT.
