On the 10th day of August, 2016, came regularly on for trial the above entitled and numbered cause and the State appeared by her District Atterney Pro Tem and the Defendant, Kristen Westfall Maddox, appeared in person in open Court, the above named counsel for Defendant also being present, whereupon both parties announced ready for trial, and the Defendant was duly arraigned and in open court pleaded Not Guilty to the charges contained in the indictment; and whereupon said plea of Not Guilty was accepted by the Court and is entered of record as the plea of the defendant; and whereupon a jury, to-wit: Larry Lovett and eleven others, was duly selected, impaneled and sworn, and the jury after having heard the indictment presented, and the Defendant's said plea of Not Guilty thereto, and having heard the evidence submitted, and having been duly charged by the Court, and having heard argument of counsel, retired in charge of the proper officer to consider their verdict and afterwards on August 18, 2016, were brought into open court by the proper officer, the Defendant and her counsel being present, and in due form of law returned into open court the following verdict, which was received by the Court, and is here now entered upon the minutes of the Court, to-wit:

We, the jury, find the Defendant, Kristen Westfall Maddox "Guilty" of the offense of Capital Murder as charged in the Indictment.

The State having elected to not seek the death penalty, the Court proceeded to assess punishment at Life Without Parole in the Institutional Division of the Texas Department of Criminal Justice in accordance with the provisions of Art. 37.071, §1 of the Texas Code of Criminal Procedure and §12.31(a) of the Texas Penal Code.

IT IS THEREFORE ADJUDGED AND ORDERED by the Court, in the presence of the

Defendant and her attorney, that the said verdict be, and the same is hereby in all things approved and confirmed, and the said Defendant is adjudged guilty of the felony offense of capital murder, committed on January 18, 2014, as charged in the indictment and as found by the jury, and it is adjudged that the said Defendant is sentenced in open Court, her and her attorney being present, to confinement in the Institutional Division of the Texas Department of Criminal Justice Institutional Division for Life Without Parole, and that the State of Texas do have and recover of the said defendant all costs in this prosecution expended, for which execution will issue.

And the said defendant is remanded to jail until said Sheriff can obey the directions of this judgment and sentence herein.
