If a designation is not filed, the clerk is required to prepare a record according to TRAP 34.5(a).</p> <p>3.) If the defendant is the appellant, the trial court clerk's record MUST include the trial court's certification of the defendant's right of appeal. (CRIMINAL CASES ONLY) TRAP 25.2(d).</p> <p>4.) An information form is available on the website that we request the clerk send along with the copy of the notice of appeal. TRAP 25.1(f) and 25.2 (e).</p> <p>5.) If you need additional time to prepare your record you will need to request an extension of time. Reporters extensions require a copy of their monthly report pursuant to TRAP 13.4.</p> <p>6.)
