

ORDER ON DEFENDANT'S MOTION TO DECLARE PLAINTIFF <u>A VEXATIOUS LITIGANT</u>

After considering defendants Saleem Ali, Sadruddin Sarfani, Mustak Ali and Amin V. Mohamed's motion to declare plaintiff, Salim Merchant, a vexatious litigant, plaintiff's response, the evidence presented at the hearing, and the arguments of counsel, the Court:

DENIES the motion.

GRANTS the motion, declares plaintiff, Salim Merchant, a vexatious litigant, and orders as follows:



2. If plaintiff does not furnish security within the time limit set by this order, the Court will dismiss this suit with prejudice against plaintiff.

- 3. This suit will remain in abatement until plaintiff complies with this order or until it is dismissed by further order of this Court.
- 4. Plaintiff must not file as a pro se party any new litigation in a court in Texas against any party without first obtaining permission from the appropriate local administrative judge as required by Texas Civil Practice & Remedies Code section 11.102(a).
- 5. As required by Texas Civil Practice & Remedies Code section 11.104, the court clerk will provide a copy of this order to the Office of Court Administration of the Texas Judicial System.
