## ORDERS ON CAUSES

19-0036 LANDRY'S, INC. AND HOUSTON AQUARIUM, INC. v. ANIMAL LEGAL DEFENSE FUND, CHERYL CONLEY, AND CARNEY ANNE NASSER; from Harris County; 14th Court of Appeals District (14-17-00207-CV, 566 SW3d 41, 10-18-18)

The Court affirms in part and reverses in part the court of appeals' judgment and remands the case to that court.

Justice Blacklock delivered the opinion of the Court.
