Guardianship in TexasOffice of Court Administration (OCA)

Judicial Branch Certification Commission (JBCC)

- The JBCC regulates certified guardians and guardianship programs in Texas.
 Certification includes a criminal history check, examination, and continuing education requirements.
- 368 certified guardians, 95 provisional guardians and 28 programs.
- Investigation of complaints against certified guardians and programs.
- The JBCC also registers all proposed guardians which includes a criminal history check and guardianship online training covering alternatives to guardianship.

Guardianship Abuse, Fraud, and Exploitation Deterrence Program (GAFEDP)

On September 1, 2019, the OCA implemented the GAFEDP to provide resources to Texas courts relating to monitoring and compliance of guardianship cases pursuant to SB 31 & HB 1286 (Zaffirini/Smithee). The audit process includes an initial baseline compliance review, financial audits, and a written report of findings with recommendations and best practices for the court. An online guardianship reporting system is in development.

Why is this important?

- Each guardianship represents the loss of civil rights and personal decisionmaking power, loss of authority to control their money and assets, and vulnerability to exploitation.
- Estimated \$4.9 billion in assets under court and guardian control in Texas.
- Throughout Texas the courts lack personnel and resources to adequately monitor cases.

A guardian is a person who is appointed by the court to protect the individual and/or property of the individual who does not have the capacity to protect his or her own interests.

- Guardianship of the Person: a guardian is appointed to take care of the physical well-being of the protected person.
- Guardianship of the Estate: a guardian is appointed to care for a protected person's property, including finances.

GAFEDP Finding Examples

- \$1.3 million in loans made from the protected person's estate without court approval.
- Certified guardian's license revoked by JBCC after a financial audit revealed a total of \$10,101.55 in cash withdrawals and other questionable purchases. \$25,000.00 fine imposed and criminal prosecution underway.
- \$30,000.00 of the protected person's funds into their own personal account to pay bills and personal living expenses.
- Guardian had not visited protected person in 20 years per annual reports.
