ORDER FINDING NOEL LIFE a/k/a NOEL CASTILLO IS A VEXATIOUS LITIGANT AS DEFINDED BY CHAPTER 11 OF THE TEXAS CIVIL PRACTICE AND REMEDIES CODE

On this day, the 23rd of April, 2025, came on to be considered Defendant Maria Teresa Martinez Motion for Order Determining Plaintiff Noel Life is a Vexatious Litigant.

After considering the motion, the pleadings, the evidence, and arguments presented by both parties, the court is of the opinion that defend Maria Teresa Martinez motion should be GRANTED and is in all things GRANTED.

It is therefore ORDERED that plaintiff is deemed a vexatious litigant as defined by Chapter 11 of the Texas civil practice and remedies code.

It is further ORDERED as to plaintiff Noel Life's lawsuit against Maria Teresa Martinez herein, that Noel Life be required to post a security bond of \$7,500.00 to the El Paso County District Clerks within 45 days after rendition of this Order. If Noel Life does not furnish said security within 45 days, June 10th, 2025 it is ordered that all of Noel Life's claims brought against Maria Teresa Martinez in the instant suit, or that could have been brought against Maria Teresa Martinez, shall be DISMISSED WITH PREJUDICE.

It is further ORDERED that Noel Life is prohibited from filing prose, a new litigation in EL PASO COUNTY within permission of the appropriate local administrative judge as described by Section 11.102(a).

THEREFORE, it is ORDERED that the clerk of the EL PASO COUNTY may not file a litigation, original proceeding, appeal, or other claim presented, pro se, by Noel Life subject to a prefiling order unless Noel Life obtains an order from the appropriate local administrative judge which is Judge Stephen Ables of Sixth Administrative Judicial Region as of the dates of this Order.

IT IS FURTHER ORDERED that a clerk of this court shall provide the Office of Court Administration of the Texas Judicial System a copy of this order not later than the 30th day after the dates this order is signed, April 25th, 2025 plus 45 days April
