"Taxing unit" means a county, an incorporated city or town (including a home-rule city), a school district, a special district or authority (including a junior college district, a hospital district, a district created by or pursuant to the Water Code, a mosquito control district, a fire prevention district, or a noxious weed control district), or any other political unit of this state, whether created by or pursuant to the constitution or a local, special, or general law, that is authorized to impose and is imposing ad valorem taxes on property even if the governing body of another political unit determines the tax rate for the unit or otherwise governs its affairs. See § 1.04(12), Tex. Tax Code. (NOTE: Calculating the filing fees in a delinquent tax case is not an empty exercise because often the filing fees are assessed as a court cost against an unsuccessful defendant.).

Texas has adopted the Uniform Enforcement of Judgments Act (UEFJA) which provides for the enforcement of a judgment of another state (known as a foreign judgment) simply by filing the foreign judgment with the clerk. See §§ 35.002 and 35.003, Tex. Civ. Prac. & Rem. Code. Once filed, a foreign judgment has the same effect as a judgment issued by a Texas court. See § 35.003, Tex. Civ. Prac. & Rem. Code. A person filing a foreign judgment must pay the amount provided by law for filing the same or similar case in a Texas state court. See § 35.007, Tex. Civ. Prac. & Rem. Code.
