### **Detailed Description of Offenses in each Misdemeanor Category**

- A Rules-of-the-Road Offense<sup>1</sup> (other than a Parking or Pedestrian Offense) that is a moving violation<sup>2</sup>
- B Rules-of-the-Road Offense (other than a Parking or Pedestrian Offense) that is not a moving violation
- C School Non-Attendance Offense (Education Code, §§ 25.093, 25.094)
- D General fine-only misdemeanor offense<sup>3</sup> that is a moving violation
- E General fine-only misdemeanor offense that is not a moving violation
- F Parking or Pedestrian Offense that is a Rules-of-the-Road Offense
- G Parking or Pedestrian Offense that is not a Rules-of-the-Road Offense.

<sup>1</sup>A rules-of-the-road offense is any offense found in Transportation Code, Chapters 541 - 600.
